E-Learning, often known as online learning, is a form of education that makes use of internet-based delivery, interaction, and facilitation methods, as well as other types of learning services(Aidah, 2019; Aulia et al., 2019; Setiawan et al., 2019; Yazdi, 2012). Edmodo is an educational technology business that delivers communication, collaboration, and coaching skills to instructors and institutions(Ariani & Helsa, 2019; Jamil, 2018; Kristiani, 2016, 2016). Teachers can use Edmodo to share content, administer tests, and manage discussions with students, colleagues, and parents. Students will also be prepared to take the national computer-based exam. One simple strategy to increase the quality and capacity of students is to use Edmodo-based elearning as a learning medium to access knowledge as widely as possible. This can be accomplished by developing an e-learning platform for schools based on Edmodo. LITERATURE REVIEW

E-learning, in its most basic form, necessitates the use of a media, also known as a platform, to facilitate e-learning activities. Nicolas Brog and Jeff O'Hara developed Edmodo in 2008 as an e-learning platform(Balasubramanian et al., 2014; Zakana & Esther Fomsi, 2019). This platform may be utilized directly by teachers and students in a classroom without the need for a dedicated server or a lengthy installation. Edmodo is a secure and simple way for students and teachers to interact and collaborate by sharing content in the form of text, image links, video, and audio. Edmodo's goal is to assist educators in utilizing social networking tools in ways that are appropriate for classroom learning. Edmodo has a design that is very similar to Facebook social media, which makes it a popular choice for teachers to utilize as an electronic learning medium because it is simple to use and does not require any special skills, and anybody with an Edmodo account can access it. Although Edmodo has many of the same features as Facebook, it is more private in terms of confidentiality.

Based on preliminary research conducted by the author, it has been determined that Edmodo serves three purposes in the learning process: substitute, companion, and supplement. Every instructor has the option of using Edmodo for functions that are specific to the needs of their students. Substitute function: These are Edmodo's current class facilities for changing the clock on classes that can't be done face-to-face, such as for students in industrial practice. Edmodo is utilized as a student learning companion medium, allowing students to study independently on materials that have been supplied by the teacher using Edmodo. The final function is Edmodo as a supplement, which includes assignments and quizzes on Edmodo, which is utilized by teachers to offer students with daily homework and exams. Students can be more independent in their learning by using Edmodo, and information that has been submitted by the teacher can be accessed by students and used as learning reference materials. Furthermore, the activities supplied through the assignment and quiz features have a processing time limit, allowing students to practice their speed and accuracy in completing the task.

METHOD

This research uses qualitative techniques combined with descriptive analysis. Informant or source is a research subject in qualitative research. Lecturers in Educational Technology courses became the primary informants in this research. The information collected in this study is preliminary information collected through interviews, observations, and documentation. Data collection techniques are based on research tools created by the authors, such as interview grids and observation protocols. For data analysis, miles and Huberman data analysis procedures are used, which consist of three stages: data reduction, presentation, conclusion withdrawal, and verification. Data reduction is made by selecting, summarizing, and focusing the data collected in the field and adjusting it to the research purpose. The data will then be presented using fishbone graphs. It would be easier to understand what happened if the data was presented in the form of a fishbone diagram. This will allow you to plan what steps to take next. The next stage is to draw conclusions and verify them. The initial conclusion of the authors of this study is that the development of technology and information affects the availability of learning media today, with the existence of internet facilities making Learning activities more accessible and fun. One of them by using Edmodo as an e-learning medium.

RESULT



Edmodo is used as a supplement to the PAI class Educational Technology Courses. In this instance, instructors are more likely to use Edmodo to provide activities and quizzes to students. 


Fig 2. Task View




Fig 3. Examples of Quiz

DISCUSSIONS

Giving students quizzes using Edmodo can save lecturers time when it comes to conducting assessments because the outcomes of student quizzes can be seen right away. This is in line with Umaroh's list of Edmodo benefits, the second of which is that it relieves lecturers of the burden of providing student assessments. Sheikh Maulana Qori Bangko, a lecturer at the Institute of Islamic Religion who also uses Edmodo, noted that the benefits of adopting e-learning, particularly Edmodo, are the features that Edmodo provides, which are very beneficial and easy to use. The Quiz feature, for example, is a little troublesome in terms of creating problems, but professors are aided since lecturers may schedule quiz work and check how many students have completed it all at once, and the results can also be directly known.

Edmodo, in addition to being used by students and lecturers, may also be used by parents to track their children's learning progress by creating a parent account. Parents of students who already have an Edmodo account can join the group in which their child is enrolled by first obtaining permission from the lecturer.

The use of Edmodo that is suited to the demands of lecturers and courses has an impact on Edmodo's flaws. In contrast to Edmodo, which is used as a replacement class for student and lecturer intensity in accessing high Edmodo, Edmodo is utilized as a complementing class of student intensity. and the number of instructors who use Edmodo isn't too large. Students normally only access Edmodo when there is a notification regarding assignments and quizzes in Edmodo, and Lecturers only access Edmodo when it gives assignments for Lecturers. This also happens in PAI classes; the average new student checks Edmodo when they receive an email notification that the Lecturer has assigned a work or quiz. Edmodo is a good place to start. According to the author's interview with many informants at the Institute of Islamic Religion, Sheikh Maulana Qori Bangko indicated that the lack of Edmodo as an e-learning medium is due solely to technical issues, which are highly reliant on the availability of internet networks.

When it comes to using Edmodo as an e-learning medium, both students and lecturers have nearly identical expectations: they want the Edmodo learning process to run more smoothly, and schools can help by providing better Wi-Fi and computer labs with sufficient resources to facilitate the e-learning process.

CONCLUSION
